A meeting of the Boyce Town Council was held at Town Hall on October 1, 2024 scheduled to begin at 6:00 p.m. with the following members present; Mayor Kelvin McCoy; Alderman Peggy Brew, Lucretia McCoy Price, Mary Fisher, Leslie Aaron and Donna Lofton. Also present were the Town Attorney, Town Engineer, Police Chief and Fire Chief. Town Clerk Shawanda Tompkins.

Mayor Kelvin McCoy called the meeting to order stating there was quorum. Fire Chief Joshua Harper led in the pledge of allegiance and Mr. Charles Robinson gave the invocation.
